Mandatory Requirements For Hire Of Samford Golden Valley Pony Club Inc. Grounds

A/ Insurance

All hirers **MUST** provide proof of adequate insurance for **ALL** participants

Unless express prior permission is obtained from the management committee of Samford Golden Valley Pony Club Inc. any rider participating in an event or any other form of training or social activity on our grounds **MUST** provide the Event Organiser with proof of Current EFA Riding Membership or current Pony Club Of Queensland Riding Membership.

Any rider who is unable to provide proof of PCAQ or EFA Insurance is expressly prohibited from using the grounds and facilities of Samford Golden Valley Pony Club Inc.

NO OTHER FORM OF CLUB MEMBERSHIP IS ACCEPTABLE

B/ Waiver Forms

The Hirer of the grounds must provide a sample of a suitable Waiver Form that is to be signed by all participants prior to using the grounds of Samford Golden Valley Pony Club Inc. for approval at least one month prior to the Hire date of the grounds

It is the responsibility of the hirer of the grounds to ensure that all riders have signed an indemnity form prior to starting the activity that the Hirer has organised

C/ Use Of Equipment

It is the responsibility of the Hirer to ensure that any equipment used in their activities is checked to be in a safe condition prior to using the Equipment

It is also the sole responsibility of the Hirer to ensure that all equipment hired is used in an appropriate and safe manner with adequate consideration given to the experience and skills of the participants

D/ Grounds Housekeeping

- i/ All stable manure & rubbish must be placed in designated areas
- ii Canteen must be left in a clean & tidy condition with all utensils washed and dried
- iii/ Toilets must be left in a clean and presentable condition
