# Zone One CIP LOYALTY PROGRAM

Metropolitan Zone One CIP will introduce in 2011 a Loyalty Program to reward and encourage loyal attendance at Zone CIP functions.

Points are allotted for attendance at Zone One CIP functions. Attendance points can be redeemed for attendance at future Zone One CIP functions.

Due to the outstanding support shown during 2011, 50% of points gained in 2010 will be carried forward into 2011.

## Loyalty Points

Attendance at Zone One CIP Functions:-

<b>Coach Development Clinic</b>	<b>10 points</b>
<b>Area Visit</b>	<b>10 points</b>
<b>Alliance Events</b>	<b>15 points</b>
<b>Officiating Clinic</b>	<b>20 points</b>

## Annual Bonus Points

100 points – attending 100% of functions  
75 points - attending 75% of functions  
50 points – attending 50% of functions

## Redeeming Points

Loyalty points are redeemed only when attending Zone One CIP Functions  
Loyalty points will be deducted at a flat rate of 40 points per Zone One CIP Function.

Example:-

Mary has 60 loyalty points and is attending a Jumping Equitation Accreditation Clinic. Rather than Mary paying a nomination fee of \$10 to attend, Mary is able to use Loyalty points. Mary will redeem 40 Loyalty points to attend the clinic. Mary will gain 20 Loyalty points for attending and thereby having a total of 40 Loyalty points after the clinic.

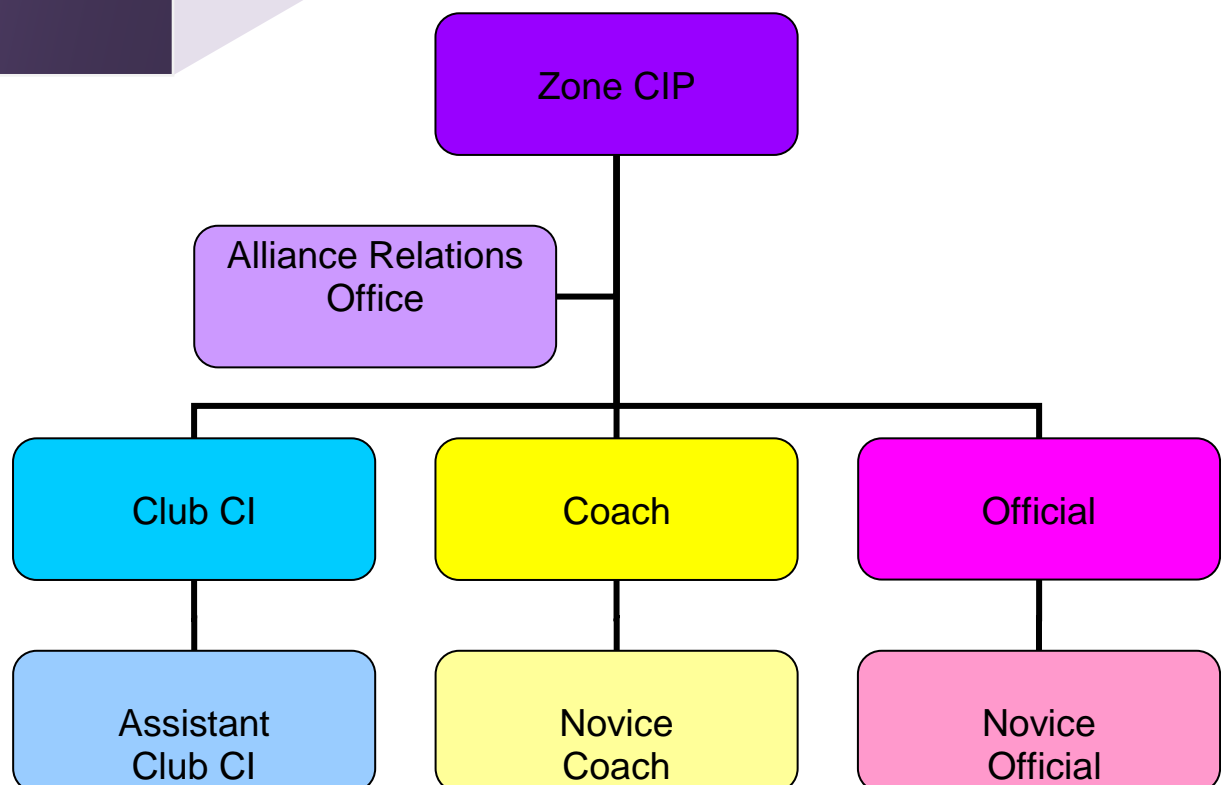
# Zone One COACH / OFFICIAL ALLIANCE

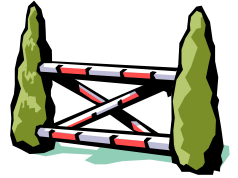
